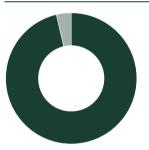

Geographic breakdown⁺

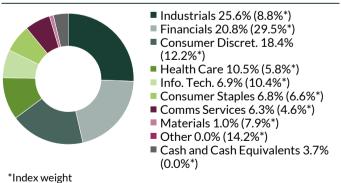
