## Investment objective and policy

The Fund aims to grow your investment over the long term.

The Fund invests in shares of companies that are listed on exchanges worldwide. The Fund may invest in both developed and emerging market countries.

The Fund invests in shares of high-quality companies which are positioned to contribute to, and benefit from sustainable development. Investment decisions use a thematic sustainability approach and an assessment aiming to identify high quality companies based on three key points: (i) Quality of management (ii) Quality of the franchise company including its social usefulness, their environmental impacts and efficiency and responsible business practices, and (iii) Quality of the company's finances and their financial performance. Sustainability is a key part of the approach.

Pursuant to the EU Sustainable Finance Disclosure Regulation (EU 2019/2088), this Fund also has sustainable investment as its objective under Article 9.

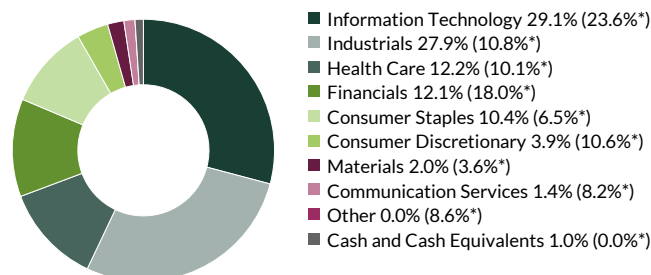

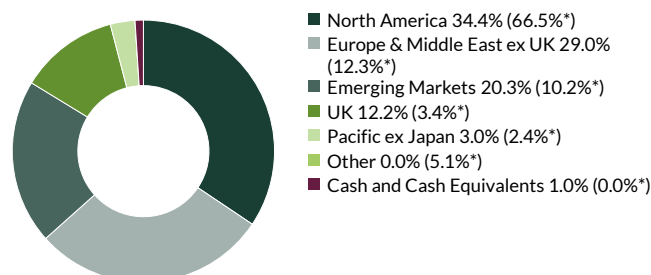
